Over five days, our young musicians will perform at four prestigious locations, including the iconic Menin Gate, representing our community on an international stage.

The total cost per participant is £623 but as an inclusive organisation, we are committed to ensuring that financial barriers do not prevent any member from taking part. To achieve this, we aim to subsidise the cost, reducing it to £500 per band member. Additionally, we need to cover the expenses for our essential volunteers who support the band throughout the trip. This grant will help make this once-in-a-lifetime experience accessible to all, fostering musical development, cultural exchange, and a deep sense of community among our young musicians.
